Wedding Photography Contract

This wedding photography agreement between Denise Lundy Photography and

agree that at all times Denise Lundy Photography shall maintain all rights to the exclusive use of the images created and reproduced, and include but are not limited to, copyright, display, or publication.

The client also agrees to provide visible written photo credit to Denise Lundy Photography on all images put forth for public display such as Facebook.

If the photographer cannot perform the Agreement due to fire or other casualty, act of God, or other cause beyond the control of the parties, or due to photographer's illness, and if we cannot secure a replacement photographer, then Denise Lundy Photography will return the deposit to the client but shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the photographer. In the event the Photographer fails to perform for any reason, Denise Lundy Photography and the photographer on assignment shall not be liable for any amount in excess of the retail value of the client's order.

The photographer is responsible for providing photographic services during the engagement session, wedding event and products after the wedding, referred to as *coverage*. RAW, unedited image files will NOT be released to the client. Only fully edited image files that the photographer deems to be of the highest print quality will be released to the client.

As per this agreement, the client will pay Denise Lundy a total sum of \$_____. This fee includes a free 2 hour engagement photo session, and _____ hours of wedding day photography at \$200 per hour beginning at _____ a.m. / p.m. and ending at _____ a.m. / p.m. A deposit of \$100 will be paid by the client at the signing of this agreement. The final payment of \$_____ is due 14 days prior to the wedding date, along with any additional payment agreed upon by the client and Denise Lundy Photography for all necessary expenses (unless otherwise specified) such as parking, fuel, travel, hotel charges, etc. **Please make checks payable to Denise Lundy.**

No photography will take place and no rights are granted until payment is made in full.

Should the date of the wedding be changed, and Denise Lundy Photography is able to accommodate the change of date, all agreed upon financial terms will apply to the new date. The client agrees to pay the full cost of any necessary legal fees, or collection fees incurred by Denise Lundy Photography to enforce this agreement.

Denise Lundy Photography will be the sole lead photography agent of the wedding event. I may, at my discretion, bring a second shooter/assistant for additional photography coverage. Friends and family of the bride and groom who wish to take pictures for personal purposes are welcome to take pictures at the reception, providing they do not interfere with the photographers' ability to perform their job. We require that ALL family and friends be respectful and follow the photographers direction during our formal photographic session.

The photographer will take formal, group and candid photographs as deemed necessary. If there are specifications, the client will inform the photographer prior to the wedding event or notify the photographer in a timely manner during the wedding day.

Since wedding photography normally involves a very long day for the photographer and assistant(s), they will need to be provided a meal at your reception—please notify your caterer and give them permission to serve us a meal.
